


## **GUIDLINES FOR FILING EQUIVALENCY TEST APPLICATION FORM**

**The candidates who have Diploma in Engineering from the State Board of Technical Education of other states through Lateral Entry after undergoing regular course of study in AICTE approved Poly technics are eligible for appearing this examination.**

1. Read the notification available in the website with almost care before submitting the application through on line. The on line registration closes on 25.07.2021.,5pm.
2. click New registration link and provide your mobile number ,Aadhar number and email id for generating application number .email id &pass word provided during the registration will be your login name and pass word.For resetting the pass word ,send on email to [eqtestdte@gmail.com](mailto:eqtestdte@gmail.com) showing the date of birth ,mobile number given at the time of registration.
- 3.Login using your login name and pass word and complete the other details .Candidates are advised to note down and keep Application Number which may be used as the identification code for future reference.
- 4.The fee for registering the examination is Rs.2000 - *for SC/ST candidates fee is Rs.1000 -(SC/ST Candidates have to produce Community /Caste certificate obtained from the competent revenue authority )*
- 5.Candidates are requested to download the challan form and fill up the chalan with the following details .Your application number as register number /Institution Id ,Name ,ET 2021 as course name ,May 2021 as month and year of examination.Then remit the application fee in **Sakthi Account number 67154609791 of the Joint controller of Technical Examination from any branch of State Bank of India.**
- 6.Update the application by providing the payment details .Updation is allowed up to the printing of the application form only.
7. Upload a passport size photo of the candidate in jpg/jpeg format of size between 15 to 50 kb for online registration.
8. Candidates are advised to keep a screen print of finally updated application form and the Application Number furnished may be used as the identification code for future reference .
9. Candidates are requested to forward the self attested copies of the certificates and mark list along with the application form to this office .Do not send original certificates long with the application .
10. Defective or incomplete applications will be rejected.Documents /Certificates furnished after submission of the application will not be entertained under any circumstances.
11. Applications received after the last date applications will also be summarily rejected.The office of the Controller of Technical Examination will not be responsible for any postal delay /loss of applications.
12. **It is mandatory to submit the downloaded hard copy of the application form along with the original chalan and copies of the certificates send to The Joint Controller of Technical Examinations ,Kaimanam p.o. ,Trivandrum-695040 . In the envelope superscribed with EQUIVALENCY TEST -2021 by registered /Speed post or in person on or before 31.07.2021 ,5 pm.online registration alone is not a claim for appearing the examination.**

13. Fee once remitted will not be refunded under any circumstances.
